



Fee Schedule & Financial Policy

Thank you for choosing Radiant Natural Health Clinic as your Naturopathic Medicine service provider. Dr. Lin continues to accept new patients. In order to provide quality service and clear communication between you and the clinic, we have implemented a Fee Schedule & Financial Policy which we require that you read, agree to and sign prior to any treatment.

FEE SCHEDULE

Extended Medical Plans usually cover care provided by Naturopathic Physicians. There are numerous policies with a wide variety of coverage. The plan may include only office visits/services or both office visits/services and lab services. We are not able to directly submit to insurance companies and therefore require full payment at time of service. We will provide you with a detailed receipt for submission and reimbursement from your insurance company. All fees are subject to 5% GST.

Comprehensive First Visit \$145

The initial visit with Dr. Lin is a comprehensive 75 minutes health history gathering session. This history includes profiling details on your current medical concerns, dietary habits, exercise, emotional wellbeing, past medical history, family history, and exposure to environmental hazards. Also in this session, pertinent physical examinations, the use of standard diagnostic instruments and laboratory tests would be performed to gather more information and make a solid diagnosis.

Subsequent Visit \$70

Follow up appointments are usually 30 minutes in length and involves case discussion, progress follow up, pertinent physical exams, and further refinement of the personalized treatment programs.

NAET (Nambudripad's Allergy Elimination Techniques) Treatment \$65

Eliminating sensitivities to food and environmental particles using the non-invasive, drug-free, natural solution known as NAET. NAET was discovered by Dr. Nambudripad in 1983 and has been used successfully internationally to help allergy sufferers. FINANCIAL POLICY

PAYMENT

Payment is due at the time of service. You may use credit card (Visa or MasterCard), debit card, cheque, or cash (exact change would be greatly appreciated) to pay for your account. Please note that all services and supplement items are subject to 5% GST.

INSURANCE COVERAGE

Your insurance policy is a contract between you and your insurance company. We are not a party to that contract. We make no claim to know neither the policy nor the type of services your insurance covers. It is your responsibility to know what services may or may not be covered by your insurance. The clinic will provide you with a detailed receipt which you can submit to your insurance for reimbursement. We encourage you to refer to your benefits manual if you have any questions about covered services.

PHONE AND EMAIL CONSULTATIONS

Dr. Lin offers both phone and email consultations. These out of the office services are free of charge for established patients if the question is related to a documented condition or treatment plan. The clinic charges \$35.00 per 15 minutes for phone consultations. The fee will be waived if an office visit is determined as required and rendered.

Email consultations are offered to established patients and will be assessed on an individual basis. No fee will be incurred if the question is related to a documented condition or treatment plan. There will be a minimum fee of \$15 for email consultation; however, you will be notified of the charges and asked to agree before receiving a response from Dr. Lin.

MISSED/LATE CANCELLED APPOINTMENTS

Please give us at least 24 hours notification if you cannot keep an appointment. This courtesy will allow others to be seen. We do realize that emergencies arise and therefore do not charge for the first missed or late cancelled appointment. Subsequent missed or late cancelled appointments are charged to your account for a fee equivalent to the amount of time booked.

RETURNED CHEQUES

Cheques with insufficient funds will be charged a \$25.00 handling fee.
